And

**Bangladesh Pipe & Tubewell Merchant's Association**, 14, Hazi Osman Goni Road, Dhaka-1000, Pho- 01730476917

**Islami Bank Foundation** (here in called the First Party) offers services in health care sector of Bangladesh and committed to render world class services at a reasonable cost, and whereas the **Second Party** desires to avail of the medical services for their **Working Employees in the organization and their dependents (Self, father-mother, spouse children) & Member "Bangladesh Pipe & Tubewell Merchant's Association"** from **Islami Bank Hospital** under the following terms & conditions:

2. Services will be rendered based on existing rate and discount will be allowed on that rate. It is mentionable that the rates may be changed from time to time and discount will be fixed on the changed rate without prior notification.
3. The discount to be provided by the **First Party** shall exclusively be applicable to the **Working Employees in the organization and their dependents (Self, father-mother, spouse children) & Member of the Second Party**. The **Working Employees in the organization and their dependents (Self, father-mother, spouse children) & Member of the Second Party** will have to show **Health card** (to be issued by the first party)/valid **ID card/Letter** or some authentic reference of the **Second Party** to avail these facilities.

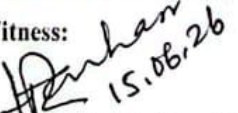

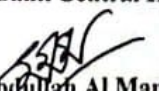
4. At the time of patient admission in ICU Tk.25,000/- and other than ICU at least Tk. 5000/- must be deposited in advance by each and every patient referred by the 2<sup>nd</sup> party. All the payments will be made in cash/credit card/DD/pay order/cheque by the **Working Employees in the organization and their dependents (Self, father-mother, spouse children) & Member** personally or officially. ICU patient's medicine and pathological tests, which are not available at our hospital, should be purchased/done by the patient himself or his/her attendant's care.
5. In case of any complication /circumstances that may arise during the course of treatment, the patient may be transferred to other medical center, if the management facilities of that complication is not available in IBH or the relevant consultant advises so, or the second party desires so, and in that case, the second party shall have to take the responsibility of the patient.
6. The **Working Employees in the organization and their dependents (Self, father-mother, spouse children) & Member** of the Second Party shall also have to pay applicable taxes & VAT, fees or charges laid under the rules of the authority for the time being in force.
7. The **First Party** agrees to maintain the confidentiality of all information related to the **Working Employees in the organization and their dependents (Self, father-mother, spouse children) & Member** of the Second Party's Medicare or treatment benefits they will avail from the **First Party** (the "Confidential Information") and shall not disclose the confidential information to any person without obtaining the **Second Party's** prior written consent. The second party also agrees to maintain the confidentiality of any discount provided by the 1<sup>st</sup> party.
8. This agreement shall come into effect in accordance with the relevant laws of the People's Republic of Bangladesh for the time being in force.
9. If any dispute arises on any matter under this agreement, such dispute shall be settled through mutual discussion between both the parties.
10. No modification or amendments of this agreement and no waiver of any of the terms and conditions hereof, shall be valid or binding unless made in writing and duly signed by both the parties.
11. This agreement shall be for 2 years. This agreement shall remain valid up to continue from the date of contract signing. It may be auto renewed after expiry of the contract if both the parties agree. But it may be terminated anytime by the first party. The 2nd party may also terminate this contract subject to 30 days prior notice in writing and after settling all bills due to the 1st party.

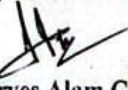

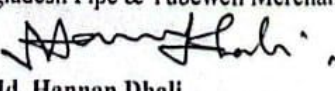
