AGREEMENT FOR CORPORATE MEDICAL SERVICES

"This Agreement for Corporate Medical Services (hereinafter referred to as the 'Agreement') is made and entered into on this 17th day of May, 2026 of the Christian era."

BETWEEN

Apollo Clinic® Licensee: JMI Specialized Hospital Ltd. having its registered premises at 64, Satmasjid Road, Dhanmondi C/A, Dhaka-1205, Bangladesh. TIN- 580071494006 represented by its duly authorized officer Dr. Tamjeed Alam, Chief Executive Officer, Apollo Clinic® Licensee: JMI Specialized Hospital Ltd.

"Apollo Clinic® Licensee: JMI Specialized Hospital Ltd. (hereinafter referred to as the 'FIRST PARTY' or 'SERVICE PROVIDER', which expression, unless excluded by or repugnant to the context, shall include its successors-in-interest, legal representatives, administrators, executors, and permitted assigns), of the FIRST PARTY."

AND

Bangladesh Pipe & Tubewell Merchant's Association (BPTMA) hereinafter referred to as having its head office on Address- 13/14 Haji Osman Goni Road – Khalada Tower 2 Floor Dhaka -1000, represented by its duly Authorized Officer Parvez Alam Chunnun-President (hereinafter referred to as the 'SECOND PARTY') which expression shall, unless excluded by or repugnant to the subject or context, mean and include its successors-in-interest, legal representatives, administrators, executors and permitted assigns of the SECOND PARTY.

WHEREAS

A. The SECOND PARTY approached to the FIRST PARTY to avail special corporate health services for its employees and their dependents (Spouses, Children, Father, and Mother). For the purposes of this Agreement, these individuals shall be ID Card member of Bangladesh Pipe & Tubewell Merchant's Association (BPTMA)

B. The FIRST PARTY is also desirous of providing special medical services to the member of the SECOND PARTY and any other person so referred to the First Party by the Second Party at a Discounted Rate as detailed in this Agreement.

ANDWHEREAS, on the basis of the mutual understanding, the parties here agree to enter into this Agreement under the terms and conditions mentioned herein below:

TERM & CONDITIONS OF THE AGREEMENT FOR AVAILING MEDICAL FACILITIES:

1. Terms of Agreement:

- That this Agreement shall be valid for a period of **10 (Ten)** years commencing from the date first mentioned above and it will be automatically renewal after each expire.
- That both the parties may, by mutual understanding change, modify and amend the terms and conditions of this Agreement in writing.
- That upon the expiry of the initial term, the parties may mutually agree to renew the Agreement for another **10 (Ten)** years' terms by a letter of extension duly signed by the authorized

2. Scope of Work:

- a) That the employees of Bangladesh Pipe & Tubewell Merchant's Association (BPTMA) shall be entitled to avail facilities (like outdoor and indoor investigations, hospitalization and medical services) rendered by the First Party with the discount facilities mentioned in this Agreement.
- b) That for availing medical services approved in this Agreement, each employee of Bangladesh Pipe & Tubewell Merchant's Association (BPTMA) upon arrival at the premises of the hospital, will be required to show his/her appropriate ID card or its photocopy to the hospital authority. However, in case of emergency, as special case, authorization by telephone for an authorized person of Bangladesh Pipe & Tubewell Merchant's Association (BPTMA) an e-mail communication for the same purpose from any of the above individuals will also be accepted by the First Party as an appropriate referral for the employee.
- c) That if a dependent of an employee or of Bangladesh Pipe & Tubewell Merchant's Association (BPTMA) wants to avail the medical services under this Agreement, he/she will be required to be accompanied by the member, will have to show the appropriate ID of the employee its photocopy at the hospital for availing the services under this Agreement.
- d) That if the First party wants to verify any ID card submitted to it by any employee of Bangladesh Pipe & Tubewell Merchant's Association (BPTMA) the First Party shall communicate with any authorized person Co Bangladesh Pipe & Tubewell Merchant's Association (BPTMA) this purpose.
- e) Both Party will be eligible for Co- Marketing through all channels (ATL/ BTL/ Digital/ any other) as per agreed conditions as well as can use Logos with permission from the organization.

4. Medical Report/Record:

- For IPD patients, the Hospital will maintain, for each patient, medical records in a register, records of investigations and key medical inferences and provide reports to the patient regularly. The Hospital shall keep confidential all the medical information and documents of each patient and shall not disclose any such information to any third party or person without prior written permission of Bangladesh Pipe & Tubewell Merchant's Association (BPTMA) and the patient.
- The parties covenant and agree to keep confidential and secret, whether stated to be confidential or not, all verbal and written communications and all other information that the parties came to know pursuant to the relationship created by this Agreement
- The liabilities of the parties under the above confidentiality clause shall remain valid and effective even after the expiration or termination of this Agreement.

5. Payment Methods:

The payment for all the services is the sole responsibility of the individual and all payment must be paid by him/her upon discharge.



6. Representation and Warranties:

Each party represents and warrants in relation to the other party that:

- a) It has all requisite corporate power and authority to execute, deliver and perform its obligations under this Agreement and has been fully authorized by all requisite corporate actions to do so; and
- b) The person(s) representing this Agreement has/have all requisite power and authority to represent the respective party and execute this Agreement.

7. Modification of Pricing:

- a) That if the First Party wishes to increase the pricing during the validity period of this Agreement, it shall provide the Second Party with prior 7 (Seven) days' written or email notice. The revised pricing shall become effective after the expiry of the said 7 (Seven) days.

8. Termination:

- a) That this Agreement may be terminated by either party by giving 30 (Thirty) days' prior notice to the other party without assigning any reason whatsoever.
- b) That any earlier termination shall not affect any receivables outstanding between the parties.

9. Successors Bond:

This Agreement shall be binding on and inure to the benefit of the respective parties hereto and their successors and assigns. The obligations and rights stated herein may not be assigned to another entity or individual without express written consent of the other party.

10. non-Assignment:

That neither party shall assign or transfer all or any part of its rights and obligations under this Agreement without the prior written consent of the other party.

11. Waiver:

Failure of either party in enforcing any provision of this Agreement shall be construed as a waiver of such provision or any other rights under this Agreement. Any waiver by a party hereto shall only be effective and enforceable against the said party if evidenced in writing and duly executed by its authorized signatory.

12. Arbitration:

Any dispute or controversy between the parties arising out of or relating to this Agreement shall be resolved amicably between the parties through discussions, failing which the dispute or controversy shall be referred to arbitration for matters of dispute to be resolved in accordance with the provisions of the Arbitration Act, 2001. The decisions of the Arbitrator(s) shall be final and binding on the parties. The place of arbitration shall be Dhaka. Joint and individual liability will be applicable in case of any act, error, omission or commission of any negligence regarding any obligation under this Agreement.

13. Governing Laws:

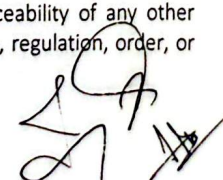
That this agreement shall be governed with and construed in accordance with the relevant laws of Bangladesh.

14. Counterparts:

This Agreement shall be executed in two (2) original copies to be printed on Non-Judicial Stamps for each of the Parties, each of which shall constitute an original but both of which constitute one Agreement.

15. Severability:

If any provision or condition of this Agreement is prohibited or rendered invalid or unenforceable, such prohibition, invalidity or unenforceability shall not affect the validity or enforceability of any other provision and condition of this Agreement and the applicable governmental rule, regulation, order, or law shall prevail.

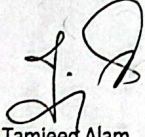
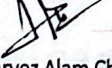
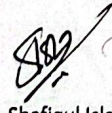
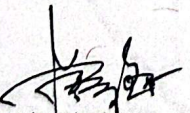
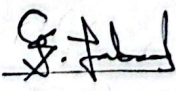
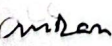
Notwithstanding the date of execution hereof, this Agreement shall be deemed to have come into effect from 31st May, 2026 in Dhaka, Bangladesh.
